RD/WR/Sec.233/Hathway/T30923726/2021/3496, dated December 3, 2021 of the Regional Director, Western Region approving the scheme of merger between Hathway Digital Limited (transferee Company or HDL) and 22 of its Wholly Owned Subsidiaries (Transferor Companies) including Hathway Media Vision Limited (HMV), which has been made effective by filing of e-Form INC- 28 on December 31, 2021 (Effective Date), the investment held by HMV in the Company i.e. 21,60,000 equity shares, has been vested into HDL with effect from closing hours of December 31 2021. The transfer of shares from the demat account of HMV to the demat account of HDL is under process. Accordingly, the shareholding pattern still reflects the name of HMV as the shareholder of the Company and the change will get reflected in the shareholding pattern of the Company for the next quarter.
